I am passionate about working collectively to achieve significant systems change that removes barriers, creates opportunities, improves access, and eliminates racial disproportionality for young people of color in the Puget Sound region.

As the Postsecondary Readiness Director at the Puget Sound Educational Service District (PSESD), I oversee regional strategies and systems alignment to increase postsecondary readiness and access across Pierce & King County including Pierce County Strong (coalition of higher education and K-12 leaders in Pierce County), the Puget Sound College & Career Network (educator network of 1,700+ in Pierce and King County), and closely coordinate with the Puget Sound Coalition for College & Career Readiness (coalition of higher education and K-12 leaders in King County). I've attended several WorkForce Central Youth & Young Adult Services meetings throughout 2016-17 as a guest presenter, to share resources, opportunities, and contribute a regional perspective.

Prior to PSESD, I managed district secondary success and college readiness programming for Highline Public Schools including a 6-year \$7 million GEAR UP grant, in-class college & career Advisory course programming, design and implementation of the High School & Beyond Planning, leadership for the AVID program as the AVID District Director, development and maintenance of college access community partnerships, identification of counseling supports, and creation of school-based college and career programming such as career exploration worksite visits.

Additionally, I worked for five years at SOAR, a regional early learning and youth development coalition. At SOAR, I designed and implemented youth development professional resources, co-convened a regional Opportunity Youth/ Out of School Youth Advisory Council, and led our organization's strategic planning and implementation process.

I earned Bachelors of Arts in Ethnic Studies & Sociology and a minor in Documentary Photography from the University of San Diego. I earned a Master's in Public Administration at the University of Washington's Evans School of Public Policy & Governance and was awarded the Daniel J. Evans Student Leadership Award for Innovative Leadership and Public Service.
