

### UNEMPLOYMENT

WorkForce Central reported an increase in Pierce County's preliminary unemployment rate, from the September 2018 rate of 4.4 percent to 4.6 percent in October 2018. This is 0.3 percentage points lower than the year-ago estimate of 4.9 percent.<sup>2</sup>

This is the lowest October unemployment rate experienced in the region over the last 10 years, while the highest in this time frame was 10.3 percent in October 2009.



#### **MONTH-OVER JOB CHANGES<sup>3</sup>**

Four industries<sup>4</sup> experienced monthover employment gains. Government experienced the largest month-over job gain with 2,100 jobs added. This is typical for October, as government agencies start hiring in response to budget allocations arriving on October 1. Construction followed with a gain of 600 jobs, followed by Education & Health Services (up 300 jobs) and Professional & Business Services (up 200 jobs).

Two industries experienced month-over job losses, led by Leisure & Hospitality (down 1,000 jobs), and followed by Trade, Transportation & Utilities (down 500 jobs). The remaining five experienced no monthover changes. Overall, nonfarm employers in Pierce County added 1,700 net jobs to the economy in the past month.

#### YEAR-OVER JOB CHANGES

From October 2017 to October 2018, seven industries experienced job growth, with the largest gains showing in Leisure & Hospitality (up 3,000 jobs), Professional & Business Services (up 2,400 jobs), and Construction (up 1,600 jobs). Government, Manufacturing, Trade, Transportation & Utilities, and Other Services added several hundred jobs each.

Education & Health Services lost 100 jobs over the year, while the remaining three industries showed no year-over changes. Overall, nonfarm employers in Pierce County have added 8,800 net jobs to the economy in the past year.

#### SUMMARY

Four industries experienced month-over job gains and seven industries experienced year-over job gains in October. Pierce County added a net of 1,700 nonfarm payroll jobs from September 2018 and 8,800 since September 2017. Pierce County's preliminary October 2018 unemployment rate of 4.6 percent is 0.6 percentage points higher than Washington's rate of 4 percent.<sup>5</sup>
