#### **Commuter Data Presentation and Discussion**

Caleb Kraai, gave a presentation regarding the commuter population in Pierce County and a progress update in identifying where people are commuting from and where they are going. The committee asked many questions:

- They are interested in knowing what salary comparisons are between the commute destination and Pierce County. Does the difference in the wages pay for the cost of commute and the individual's time? What is the true cost of the commute gas, time, parking, increase maintenance on car?
- Another question was the forecast from WASDOT and Puget Sound Regional Council on growth in commute patterns.
- Caleb thanked the committee for their questions and feedback. He outlined the next phase
  of the project to take the data to a more detailed level with 3 digit NAICS codes, look at
  wages and to talk to WASDOT about the future of road construction and how much of it
  will be in Pierce County.

The committee agreed to cancel the December meeting and to meet on January 22, 2018 for 1.5 hours to accommodate a full agenda.
