I. Comment Card Reports (Review and Discussion)

- Lori shared the Employer Quarterly report (175 responses). Noted there are some job seekers completing this comment card versus the job seeker card. Center staff are working on determining why and redirecting them to the correct card.
- Job Seeker Quarterly Report (over 400 responses). Mostly positive responses and some suggestions on more workshops, particularly for the mature worker. Customers have also asked if the comment card could be created in Spanish and the Center Operations team is discussing this request.
- Lori asked the subcommittee to find ways to up completion in their respective organizations.

II. Referral System Development (Information and Discussion)

- Brand name: Common Referral System powered by 211 and United Way
- After feedback Lori created a one-page 'key words" that will help navigators determine which agency a customer should be referred. After one additional change suggested by Jaime she will send to all to use however it works best for each agency and talk to Corey about putting it on the smart sheet.
- Partners provided updates on how the system is working.

Action:

• Lori will work with Corey about putting the Key Words document on the smart sheet.

III. Community Outreach (Tamar)

- Tamar Jackson, WFC's Community Engagement Director shared that his job is to implement a strategic engagement plan and organize outreach with WFC and partner organizations.
- He would like to connect with those doing outreach in the community for each organization to build something together and learn from each other.

- After discussion, it was decided that an outreach group of this subcommittee will begin meeting quarterly beginning in May to share information and build a relationship. Tamar would be put on the June agenda of the subcommittee to report out how things are going and on a monthly basis do a summary writeup that can be shared with the subcommittee.
- On behalf of the subcommittee, Tamar will ensure with the group that when making referrals that they be codified with the Common Referral System.

Action:

- Subcommittee will send to Debbie the names/contact information of those they would like to be considered for the Business Solutions Team.
- Tamar to convene quarterly meetings beginning in May, be on the agenda for June's subcommittee meeting and provide a summary writeup of happenings that can be shared with the subcommittee on a monthly basis.

 - Lori sent the Leadership Committee a draft of business plan and asked that they read it prior to the meeting that is scheduled for this afternoon. The plan is to get them to approve it today.
 - They are all committed to getting Salesforce licenses. ESD is committed but cannot use systems that are on cloud based so a workaround will be needed.
 - We will reach out to gather names for the newly formed Business Solutions Team and begin the startup phase with meetings in May, June and July.
 - Lori met with April Gibson, WDC Chair who really pays attention to business needs. May invite her to the first Business Solutions Team meeting to share her vision.
